DLA Piper has advised Castlelake L.P., an international alternative investment firm specializing in asset-based private credit investments, on the establishment of a new joint venture with Samhällsbyggnadsbolaget i Norden AB (publ) ("SBB"), a significant social infrastructure property

company in the Nordic region. This joint venture will generate cash proceeds to SBB of approximately SEK 5.2 billion (EUR 470m).

The funds will be used by SBB Infrastructure to acquire properties from SBB and refinance debt, with the loan secured by a portfolio of social infrastructure and purpose-built care assets across Sweden, as well as additional collateral in Finland. The estimated market value of these assets is SEK 5.7 billion, with the total pool of collateral for the loan reaching SEK 9.4 billion.
